# COMMISSION IMPLEMENTING DECISION

of 19.11.2021

## amending Decision C(2020) 8794 on the financing of humanitarian aid actions from the 2021 general budget of the European Union

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012<sup>1</sup>, and in particular Article 110 thereof,

Having regard to Council Regulation (EC) No 1257/96 of 20 June 1996 concerning humanitarian aid<sup>2</sup>, and in particular Articles 15(2) and (3) thereof,

Whereas:

- (1) On 16 December 2020, the Commission adopted Implementing Decision C(2020) 8794<sup>3</sup>.
- (2) On 28 June 2021, the budget was increased by EUR 328 955 455<sup>4</sup>.
- (3) The overall amount of the budgetary allocation is now increased by EUR 258 679 451,43. The increase in the budgetary allocation is financed with EUR 30 000 000 from the mobilisation of the Solidarity and Emergency Aid reserve, EUR 79 035 655,43 from transfers<sup>5</sup> and EUR 149 643 796 from the Draft Amending Budget 5/2021.
- (4) In order to ensure the continuation of the implementation of the humanitarian aid actions of the Union for 2021 and their financing, it is necessary to adapt the total Union contribution and subsequent budgetary allocation in the measures listed in the Annex.
- (5) Therefore, Commission Implementing Decision C(2020) 8794 should be amended accordingly.

- (6) The measures provided for in this Decision are in accordance with the opinion of the Humanitarian Aid Committee established by Article 17(1) of Council Regulation (EC) No 1257/96,

HAS DECIDED AS FOLLOWS:

*Sole Article*

Implementing Decision C(2020)8794 is amended as follows:

- (1) Article 2 is replaced by the following:
- “1. The maximum Union contribution for the implementation of the Union-funded humanitarian aid actions for 2021 is set at EUR 2 005 933 645,43, and shall be financed from the appropriations entered in the following lines of the general budget of the Union:
- (a) budget line 14 03 01: EUR 1 930 933 645,43;
- (b) budget line 14 03 02: EUR 75 000 000.
2. The amount referred to in the first paragraph may include contributions from other donors to the general budget of the Union as external assigned revenue as provided for in the relevant agreements signed with such donors.
3. The appropriations provided for in the first paragraph may also cover interest due for late payment.
4. The implementation of the part of the Union contribution in paragraph 1 pertaining to Draft Amending Budget 5/2021 is subject to its adoption.
- (2) The Annex is replaced by the text in the Annex to this Decision.
